Argus Ranch – COVID-19 Liability Waiver

Coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization (WHO). COVID-19 is extremely contagious and is believed to spread mainly from person to person contact. As a result, federal, state & local governments and federal and state health agencies recommend social distancing and, in many locations, have prohibited the congregation of large groups of people.

Please read this carefully. By signing this form you are making the acknowledgments below, and releasing and waiving all claims and holding Argus Ranch harmless from all risks and damage resulting from any exposure to COVID-19 suspected to be or actually related to your attendance or participation for any activity on Argus Ranch. "Argus Ranch" shall include all owners, employees, independent contractors, club organizations and all other agents of Argus Ranch.

I acknowledge the contagious nature of COVID-19 and the inherent risk and danger of attending public events. I acknowledge that the CDC and other health authorities, together with governing state and local regulations, recommend or requires social distancing and other measures depending on the form of activity and proximity of other people. I voluntarily seek to utilize the facilities and services of Argus Ranch and acknowledge that attendance or participation in Argus Ranch events poses an inescapable risk of COVID-19. I acknowledge that I have considered that risk in balance with my and my family's circumstances and health, and have willingly chosen to proceed with my attendance and participation.

I acknowledge that while Argus Ranch will be taking measures to minimize the risk and maximize the safety of all attendees and participants and Argus Ranch persons, that Argus Ranch cannot guarantee that I will not become exposed or infected with COVID-19, and that the risk of becoming exposed to and/or infected by COVID-19 may result from the acts, omissions, or negligence of myself and others, including, but not limited to, Argus Ranch owners, employees or agents, and other attendees and participants. I acknowledge that while Argus Ranch will take reasonable measures and make a good faith effort to advise as to any potential exposure due to a person who has been on Argus Ranch who is known to have been exposed or infected, Argus Ranch is not liable for any failure to do so.

I understand it is my full and sole responsibility to keep abreast of current CDC recommendations, state and local health department recommendations, and state and local government recommendations and regulations, and I agree to follow such recommendations and regulations. I agree to follow all requirements and recommendations posted by Argus Ranch or otherwise provided to me, at all times when on Argus Ranch property.

I further attest to the following, which attestation shall include any minors for whom I have brought with me and/or am responsible for while on Argus Ranch property.

I am not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell. If I have been experiencing any of these symptoms in relation to allergies or the flu or other health condition and have been tested negative with COVID-19 since the onset of symptoms, I agree to provide proof of the negative test to Argus Ranch upon request. I understand that even if I believe that any of my symptoms are unrelated, that I will disclose them and that Argus Ranch has sole discretion whether to allow me to continue attendance or participation, whether I have a negative COVID-19 test or not.

I have not traveled internationally within the last 14 days.

I have not travelled to highly impacted areas within the USA within the last 14 days, with "high impact" defined as either statistically high overall numbers in relation to the population or a significant growth rate of recent cases.

I do not believe I have been exposed to someone with a suspected and/or confirmed case of COVID-19.

I am following all CDC and other health department guidelines and governmental regulations, and have done so for at least the 14 days prior to being at Argus Ranch.

I acknowledge that should any of the above physical symptoms present themselves while at the event that I will have to advise Argus of the same, advise of all locations where I had been, all persons with whom I have interacted, all known surfaces I have touched, and immediately leave the property.

I acknowledge that Argus Ranch has the right in its sole discretion to ask me to leave the property if there is any concern about me having been exposed to or affected with COVID-19, such as if I am showing symptoms consistent with exposure, and/or if I am failing to follow the recommendations of CDC or state or local health authorities, state or local regulations, or any regulations provided by Argus either by physical posting on the grounds or otherwise provided to me. If asked to leave, I agree to advise as to any areas I have been, persons I have interacted with, and surfaces I have touched

I understand that any fees I have paid to Argus Ranch are nonrefundable if I am unable to attend or participate.

Affirming and acknowledging the above, in consideration of being permitted to utilize the services and programs of Argus Ranch:

I hereby release and agree to hold Argus Ranch LLC, its owner (Jordan Biggs), an event giving club, their members, directors, governors, agents, event secretary, any employee or volunteers of the aforementioned parties, organization, judge, instructors/teachers, instructors/teachers assistants., and any organization AKC (American Kennel Club), NADAC (North American Dog Agility Council), USDAA (United States Dog Agility Association), CPE (Canine Performance Events), UKI (UK Agility International), approved judge harmless from and waive any and all causes of action, claims, demand, damages, costs, expenses, and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, by Argus Ranch, or that may otherwise arise in any way in connection with attendance or participation in an Argus Ranch activity. I understand that this release discharges Argus Ranch from any liability or claim that I, my heirs, or any personal representatives or other agents may have against Argus Ranch with respect to any injury, illness, death, medical treatment, or property damage that may arise from or in connection to any services related to Argus Ranch. I understand that while Argus Ranch will make a good faith effort to take reasonable precautions to minimize the risk to its attendees, participants, and persons with Argus Ranch, that this release extends to any damage caused by negligence on the part of Argus Ranch or other persons attending or participating in the activities at Argus Ranch to the full extent allowed by law.

I further agree that the above release, waiver and hold harmless provision extends to any minors for whom I have the legal right to make such release, waiver and hold harmless provision for, including minors that I am responsible for while at Argus Ranch or with whom I come into contact in the 14 days after the last day of being at Argus Ranch. These includes the following minors who are at Argus Ranch with me:

I understand that this agreement is separate from and does not change any other agreement I may have with Argus Ranch, including any other waivers, release and hold harmless agreements. Any claim arising from or relating to this waiver is limited to venue and jurisdiction in King County, Washington. If any provision of this agreement is deemed invalid, the remainder shall remain in full force and effect.
