**Trial Information:** Trial statistics and other pertinent information will be posted at [www.k-9sports.com](http://www.k-9sports.com).

**Surface:** The surface we will be holding our agility trial on is astro turf, which will provide a uniform, beautiful surface for our event. However, we cannot puncture the surface with tent stakes, or camp overnight, or feed dinner to our dogs on the field. We may put up day tents with sand bags or gallon water jugs only, provide water for our dogs and ourselves and provide dry treats for the dogs. Please do not drive your car on the turf. Please help us take care of the privilege of holding this spectacular event in this venue. The members of the Olympic Kennel Club thank you!!

**Move-ups:** The deadline to send in your move-up is Monday, Aug 9, 2021 at 6:00 pm. Move-ups must be submitted in writing (email ok).

**Height Cards/Measuring:** We will have a VMO available for measuring. All dogs without height cards will have to be measured, including 24" and 24C" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a measuring official available to measure dogs in the morning each day near the trial secretary's table.

**Due to low entry numbers we have decided to change to one judge. Ken Boyd will now be judging all the classes all 3 days. Per AKC Rules, if you wish to cancel your entry due to the judge change, you are entitled to a refund of only those classes affected. That is, you can only get a refund for the classes you entered that would have been judged by Oksana Syrkin.**

**Because of this judge change we are also changing the class run order. Please note the new order below, alternating rings starting with Ring 1.**

**Start Time & Running Order:** Check in and measuring time will begin at 7:00 am each day. **First dog on the line on ALL DAYS will be at 8:00 am.** This will be a 2 ring, 1 judge trial. The class running order will be as follows:

**Off Leash Areas:** Dogs must be on leash at all times. **And PLEASE pick up after your dogs.**

**General Parking:**

- General parking is available daily in the north and **south** parking lots beginning at 6:00am. The parking fee is \$7.00 per day.
- No exercise pens, set-ups or overnight parking in general parking areas.**
- Vehicles illegally parked may be towed at owner’s expense with no prior notification.**

**Directions to Enumclaw Expo Center (45224 284<sup>th</sup> Ave. SE, Enumclaw, WA ):**

From Seattle: I-5 to Auburn Exit (Highway 18), then 3 – 4 miles to Enumclaw Exit. Take a left at the stoplight. Approximately 15 miles to Enumclaw then follow signs to fairground.

From Tacoma: I-5 North to Auburn Exit. Then same as above.

From Spokane: I-90 West. Out of North Bend will be signs for Auburn (Highway 18 or Tiger Mountain Road.) Stay on highway until Enumclaw Exit. Continue 10 – 15 miles, then follow signs to fairgrounds.

**Set Up Time:** We will have access to the agility field area AFTER 5PM on Friday. Plan on setting up your space after that time.

**Crating:** There will be plenty of space on the field for you to set up your tent for crating. Please note, again, we are not allowed to puncture the field turf with tent stakes. All tents must be anchored with water jugs or sandbags. There is no shade on the field so if you want shade for your crating area you'll need to bring your own. **Please don't leave dogs unattended on the field after the trial. The field will be CLOSED 1 hour after the last run finishes.**

**Food:** There will **NOT** be food available at the agility area. However, there will be food vendors located at the conformation area, a short walk from the agility field. **OR PLAN ON BRINGING YOUR OWN FOOD**
