Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at K9sports22@gmail.com or by phone (503) 840-4303 (cell).

SITE INFO: This show site is indoors on artificial turf. **DUE TO COVID-19 RESTRICTIONS THERE IS NO CRATING ALLOWED IN THE BUILDING AT THIS TIME. It is preferred that you crate out of your vehicles. Also, there is plenty of space outside the arena building to set up tents for crating out of.** We will not be responsible for any lost or damaged items left at the show site. NO EX PENS ALLOWED.

Please bring your own crate, clean up supplies & water for your dog. **X-pens are NOT permitted at the show site.** Dogs must be kept on leash when not in the ring, excepting when in the fenced off leash area. A warm-up area will be provided for all exhibitors. **You may set up your crating space Saturday morning beginning at 9 am.**

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. *Please NO SPIKE SHOES OR HEELS on the mats. Please wear/use clean, athletic footwear to preserve the flooring!*

Barking dogs must be kept quiet at all times in consideration of the neighbors.

DIRECTIONS TO THE TRIAL SITE:

From the North: Take I-205 southbound to Exit 10 toward Molalla. Merge onto 213 / S. Cascade Highway / Washington Street. Turn left onto S. Beaver Creek Road. At the hard turn in the road, stay to the left. Turn right onto Windy City Road. Turn Left onto S. Gard Road. Clear Mind Agility Hall is on the left.

From the South (Canby and points South): Take I-5 North to Exit 271, Woodburn / OR-214. Turn right onto OR214. Continue onto OR-211 N/Molalla Road/ Woodburn Estacada Hwy NE. In approximately 16 miles continue onto S. Beaver Creek Road. Turn left onto S. Windy City Road. Turn left onto S. Gard Road. Clear Mind Agility Hall is on the left.

COVID-19 FACILITY GUIDELINES:

IN ADDITION to current Oregon face covering policies in effect at the time of final confirmation, proof of COVID-19 vaccination will be required upon entry, with acceptable forms of proof being a CDC vaccination card, a photocopy of the card or a photo of the card on a mobile device. Cardholders must be at least two weeks past receiving their second dose in a two-dose series (Pfizer-BioNTech or Moderna), or a single-dose Johnson & Johnson vaccine. If you have this, it is requested that you help us out and mail a copy of this card in with your entry so that we can have you checked off when you arrive to the facility. For those who cannot provide proof of vaccination, documentation of a negative PCR test taken within 48 hours of the start of the competition will also be accepted. **These guidelines apply to ALL attendees to the competition, whether entered or not.**

FOOD: There will NOT be a food vendor at the trial this weekend. Please plan accordingly.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

MOVE-UPS: No move-ups at this event.

REMINDER ON WORLD TEAM TRY OUT QUALIFICATIONS:

The first ISC Standard and ISC JWW runs on Sunday are designated as the World Team Tryout qualifying runs.

ISC Combined Class Winners Combined scores from ISC Jumpers and Standard classes at the above events will be used to award the Combined ISC Class Award. To be eligible for the Combined ISC Class Award the team must have a minimum of one clean ISC run and a run that has a maximum of 5 course faults (no time faults allowed) for those scores to be used to compute the Combined Score. The Combined Class winner from the 12, 16 and 24 inch height is invited to attend Team Tryouts. They do not need to fulfill the requirement of the 6/6 scores. The team must also send in all the required information with the fees and the entry form and meet all the other basic eligibility noted in this document (including an approved pedigree). The handler at tryouts must be the same handler that won the combined award.

FINAL ROUND RULES:

At the conclusion of the three scheduled ISC runs on Saturday (JWW/STD/STD) there will be a FINAL event. This will be an additional event with at least one contact (TBD) and it's just for fun, honor and prizes! The top five dogs in each height are eligible to run in the final at the end of the day. ***Preferred and Championship divisions will run together in each height for the Final.*** Eligibility will be determined by the combination of scores from the three previous ISC runs. The five *lowest scoring dogs* at the conclusion of the three rounds (time plus faults) will be eligible for the final round. All competitors start with zero points for each ISC run, and faults add points to that starting score of zero.

Scoring is as follows:

STANDARD FAULT: 5 points

REFUSALS/RUNOUTS: 5 points

ELIMINATION/WRONG COURSE: 100 points

ABSENCE: 200 points

TIME: added to the score

The total of time plus faults over three rounds will determine who the finalists are in each height.
