SITE INFO: This trial will be held in two rings outdoors on grass. There will be crating on the grass around the outside of the rings. **You will be able to set up after 2pm on Thursday. Please do not set up your space until the rings are fenced off to avoid putting your canopy too close or in the way of the ring.**

GENERAL WALK THROUGHS: Walk through sections will be marked on the running orders and copies will be posted in multiple locations around the building.
