## **Running Order and Class Information**

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at [K9sports22@gmail.com](mailto:K9sports22@gmail.com) or by phone (503) 840-4303 (cell).

**SITE INFO:** This trial will be held in two rings indoors on dirt. There will be limited crating inside the building. We recommend using crates instead of xpens to make room for more exhibitors. There will also be crating outside under the covered area adjacent to the arena. **You will be able to set up after 8am on Friday. Please keep your set ups against the wall in the arena so we have room to set up the rings.**

**SPECIAL NOTE:** For those that will be staying at the Best Western hotel. Please note, they typically do not allow dogs but do so for us because we have shown over the years, respect for their property. However, last year there was apparently numerous competitors that caused damage to the rooms. PLEASE, if your dogs are on furniture, put blankets or mats over the furniture. Pick up after your dogs. Don't leave the rooms in a mess or we will not be allowed to come back. Don't give AKC or MBKC a bad name.

Also, since we technically do not rent the arena until Friday, please wait until then to do any set ups. We will be there around 8am to start ring set ups. Please, wait until we get work tables and displays arranged in the concrete area before setting up your crates. Thanks!

## **DIRECTIONS TO THE TRIAL SITE:**

**From the North (Madras):** Take US-26 south to Prineville, Oregon. Turn right on N. Main St (SR-27) and go approximately ¾ mile to the entrance.

**From the South/West (Redmond):** Take SR-126 east to Prineville, Oregon. Continue east on US-26 (W 3<sup>rd</sup> St) for approximately ½ mile, then turn right on N. Main St (SR-27) and go approximately ¾ mile to the entrance.

**AGILITY GATE APP:** We will be using the Agility Gate App at this event. The code is 4303. If you don't yet have the App on your phone or tablet, go to the Play Store, search Agility Gate and download the free app.

**MEASURING:** All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

**MOVE-UPS:** The deadline for move-ups is Monday, September 26th at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

**VOLUNTEERS:** You, the volunteers, help make our trials a success. We will be giving out vouchers for future entries. Thanks in advance for helping to keep the trial running smoothly.

**Walk through groups may be changed at the trial to accommodate for workers.**

**GENERAL WALK THROUGHS:** Walk through sections will be marked on the running orders and copies will be posted in multiple locations around the building.

**PREVENTIVE ITEM:** We're recommending that all of you take your temperature in the 2 days prior to the trial. If it's elevated, it could be a sign that you're getting sick. If it is elevated, then stay home. This will help in not spreading the virus.

**CONFLICTS:** We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

**FOOD:** There will be not be a food vendor on site this year. There are fast food locations and grocery stores in Prineville within a few miles of the show site.

**B MATCH**

Thirty minutes after the trial ends on **Saturday**, there will be a B match. A B Match runs exactly like a show, but with no scoring. You may use toys and you can train in the ring. There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.
