Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at K9sports22@gmail.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the elevated area in front of the bleachers. **Indoor crating will be on a first come first served basis.** All we ask is that you **DO NOT** crate dogs along the railing overlooking the arena. You may set chairs along the railing. Xpens will be allowed as long as you **DO NOT** create large living room areas. **You will be able to set up after 4pm on Thursday. If you manage to find a way in and set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area and worker crating. PLEASE ABIDE BY THE TIMES WE GIVE YOU. WE DO THIS FOR A REASON. See the diagram below for crating layout.**

DIRECTIONS TO THE TRIAL SITE:

From the North, on I-5:

1. Take EXIT 234A toward Fair/Expo/Knox Butte.
2. Turn slight right onto Airport Road SE
3. Turn right onto Pacific Blvd. SE/OR-99E N.
4. Stay straight to go onto Knox Butte Road E.
5. End at 3700 Knox Butte Road E.

From the South, on I-5:

1. Take Exit 234 toward Fair/Expo/Knox Butte.
2. Turn right onto Knox Butte Road E.
3. End at 3700 Knox Butte Road E.

AGILITY GATE APP: We will be using the Agility Gate App at this event. **The code is 4303.** If you don't yet have the App on your phone or tablet, go to the Play Store, search Agility Gate and download the free app.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

MOVE-UPS: The deadline for move-ups is Monday, February 20, 2023 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

VOLUNTEERS: You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**. The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

FAST CLASS WALK THRU We will have an open walk thru for ALL FAST prior to the start time (walk thru will last about 30 minutes – while T2B is running).

Walk through groups may be changed at the trial to accommodate for workers.

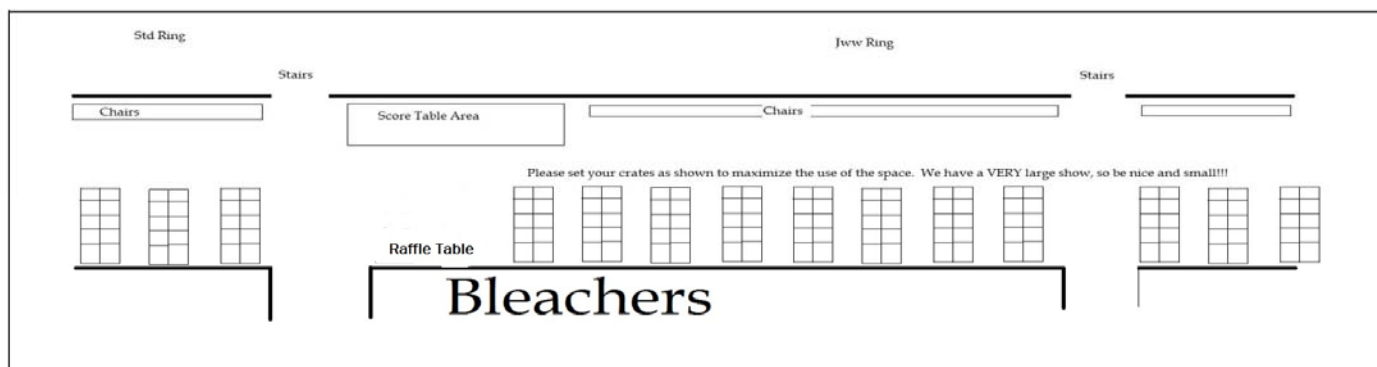
GENERAL WALK THROUGHS: We will be doing more walk throughs with smaller groups. Walk through sections will be marked on the running orders and copies will be posted in multiple locations around the building.

PREVENTIVE ITEM: We're recommending that all of you take your temperature in the 2 days prior to the trial. If it's elevated, it could be a sign that you're getting sick. If it is elevated, then staying home. This will help in not spreading the virus.

CRATING: There will be crating on the elevated area in front of the bleachers. **Indoor crating will be on a first come first served basis.** We ask that you **DO NOT** crate dogs along the railing overlooking the arena. You may set chairs along the railing. **You will be able to set up after 4pm on Thursday. If you manage to find a way in and set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area and worker crating.**

There is also crating available outside under the overhang in front of the arena building. You are free to set up crating spaces out there any time beginning at 3pm on Thursday.

Because we have such a large entry we're asking you all to crate like the diagram below. This will maximize the number of crating spaces we can squeeze in. Please do NOT crate in the score table area, raffle table area or along the railing where the chairs will be located. If you do, we may end up moving your items.



CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

FOOD: We have been told that there will not be the regular food vendor that we have had in the past. Our understanding is that a food truck will be outside near the courtyard area. They will have hotdogs and hamburgers.
