Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at K9sports22@gmail.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the area outside the arena, around the bleachers. **WE ARE OPENING UP CRATING ON A FIRST COME FIRST SERVE BASIS.** If you do crate inside we're gonna come to you first if we need workers. Please bring chairs, crates, water and clean up tools for your dogs. **You will be able to set up after 4pm on Thursday. If you manage to find a way in and set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area.**

DIRECTIONS TO THE TRIAL SITE:

From North of Eugene

Travel south bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7th Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11th Ave. at the light. Turn left on Polk Street and travel to 13th Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

From South of Eugene

Travel north bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7th Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11th Ave. at the light. Turn left on Polk Street and travel to 13th Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

FIRE AND EVACUEES: In case you haven't yet heard, there is a large fire East of Eugene. I was contacted by the Fairgrounds to let me know that they will be housing animals that have been evacuated from their homes. This means that we will NOT be able to park or walk dogs behind the arena building that we will be in. The covered pavilion behind our building will be used to house all the animals. **DO NOT PASS THROUGH THOSE BARRIERS!!!** Those animals may be afraid of dogs and we don't want to cause any problems for them or us. Stay in the front of our building and the small grass area on the side of it in front of the Ice Arena.

And for those of you that have reserved RV spaces, we will NOT be able to park in any of those spaces behind the arena building. I will send out RV parking info in a separate email with instructions on what spaces will be available for us.

Thanks for your patience and understanding.

AGILITY GATE APP: We will be using the Agility Gate App at this event. The code is 4303. If you don't yet have the App on your phone or tablet, go to the Play Store, search Agility Gate and download the free app.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

COURSE MAPS: Per AKC rules, we are not allowed to release course maps until the day of the trial. We are only required to have a posting copy available on site. As a courtesy to you, I will post course maps on my website (k-9sports.com) some time after midnight of the trial day. An email will be sent out to you prior to the trial with a link to the pages where the maps will be posted and instructions for how they work. **PLEASE DO NOT TEXT ME AT 5AM IF THEY ARE NOT AVAILABLE. I DO THE BEST I CAN TO ACCOMMODATE BUT SOMETIMES I FALL ASLEEP BEFORE I RECEIVE THE MAPS.**

FAST CLASS WALK THRU We will have an open walk thru for ALL FAST prior to the start time (walk thru will last about 30 minutes – while T2B is running).

Walk through groups may be changed at the trial to accommodate for workers.

GENERAL WALK THROUGHS: Walk through sections will be marked on the running orders and copies will be posted in multiple locations around the building.

MOVE-UPS: The deadline for Pre-Trial move-ups is Monday, Aug 21st at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

VOLUNTEERS: You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**. The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

PREVENTIVE ITEM: We're recommending that all of you take your temperature in the 2 days prior to the trial. If it's elevated, it could be a sign that you're getting sick. If it is elevated, then stay home. This will help in not spreading the virus.

CRATING: WE ARE OPENING UP CRATING ON A FIRST COME FIRST SERVE BASIS. If you do crate inside we're gonna come to you first if we need workers. **WITH THE LOW ENTRIES WE ARE REALLY GOING TO NEED YOUR HELP TO KEEP THINGS RUNNING.**

There is also crating available in the dirt arena behind the livestock building. You are free to set up crating spaces back there any time beginning at 2PM on Thursday.

SORRY, WE WILL NOT BE ABLE TO RENT THE COVERED PAVILION SPACE OUT BACK THIS TIME. SO, NO PARKING UNDER THERE.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Mark your dog as a "Conflict" on the gate up.

FOOD: There will NOT be a food vendor on site at our arena. Please bring your own food items.

There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.
