SITE INFO:

This trial will be held in one ring outdoors on grass.

Directions to Argus Ranch (35612 212th Way SE, Auburn, WA 98028):

<u>From the North/South I-5 or SR 167</u>: Exit at Hwy 18 East, take exit for Auburn-Black Diamond Road East, keep right. Turn right at SE Green Valley Rd. (just past Neely Mansion). Turn right onto 212th Way SE. Then turn left into Argus Ranch driveway. Follow signs for parking.

<u>From SR-169 Southbound:</u> Turn right onto Roberts Dr. (in front of coal car). Follow Roberts Dr. approx 4 miles. Turn left at 218th St., Bottom of the hill is a stop sign. Go straight across over the cement bridge and take the first left into Argus Ranch driveway.

<u>From SR-169 Northbound:</u> Turn left at SE Green Valley Rd. Follow Green Valley Rd., approx 4 miles. Turn left at 212th Way SE, then take the first left into Argus Ranch driveway.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

REMINDER ON WORLD TEAM TRY OUT QUALIFICATIONS:

The Level 3 ISC STD on Saturday and Level 3 ISC JWW on Sunday are designated as the World Team Tryout qualifying runs.

ISC Combined Class Winners Combined scores from ISC Jumpers and Standard classes at the above events will be used to award the Combined ISC Class Award. To be eligible for the Combined ISC Class Award the team must have a minimum of one clean ISC run and a run that has a maximum of 5 course faults (no time faults allowed) for those scores to be used to compute the Combined Score. The Combined Class winner from the 12, 16, 20 and 24 inch height is invited to attend Team Tryouts. They do not need to fulfill the requirement of the 6/6 scores. The team must also send in all the required information with the fees and the entry form and meet all the other basic eligibility noted in this document (including an approved pedigree). The handler at tryouts must be the same handler that won the combined award.
