SITE INFO:

This trial will be held in one ring indoors on artificial turf. **Please don't arrive more than 1/2 hour before the morning briefing.**

The show site is indoors on artificial turf. Please bring your own crate, clean up supplies, & water for your dog. **X-pens are NOT permitted at the show site.** Dogs must be kept on leash when not in the ring, excepting when in the fenced off leash area. A warm up area will be provided for all exhibitors.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

Please NO SPIKE SHOES OR HEELS on the turf. Please wear/use clean, athletic footwear to preserve the flooring!

Barking dogs must be kept quiet at all times in consideration of the neighbors.

From the North: Take I-5 southbound to Exit 283 Wilsonville Rd., Wilsonville. Turn right onto SW Wilsonville Rd. Stay on Wilsonville Rd for approx. 5.5 miles. Turn right onto SW Ladd Hill Rd. Stay on Ladd Hill Rd. for approx. .7 mile. Turn left onto SW Kramien Rd.. Follow Kramien Rd for approx. .5 mile. Turn right on Parrott Mountain Rd., follow Parrott Mountain Rd for .7 mile. Turn left onto NE Corral Creek Rd. Stay on Corral Creek Rd for 1.9 miles. Corral Creek Dog Sports will be on your right.

From the South: Take I-5 North to Exit 283, Wilsonville Rd., Wilsonville. Turn left onto SW Wilsonville Rd. Stay on Wilsonville Rd for approx. 5.5 miles. Turn right onto SW Ladd Hill Rd. Stay on Ladd Hill Rd. for approx. .7 mile. Turn left onto SW Kramien Rd.. Follow Kramien Rd for approx. .5 mile. Turn right on Parrott Mountain Rd., follow Parrott Mountain Rd for .7 mile. Turn left onto NE Corral Creek Rd. Stay on Corral Creek Rd for 1.9 miles. Corral Creek Dog Sports will be on your right.

From 99W: Turn South onto NE Corral Creek Rd. Follow for approx. 2.8 miles. Corral Creek Dog Sports will be on your left.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

MOVE-UPS: No move-ups at this event.

REMINDER ON WORLD TEAM TRY OUT QUALIFICATIONS:

ISC Combined Class Winners Combined scores from the WTB designated ISC Jumpers and Standard classes at the above events will be used to award the Combined ISC Class Award. To be eligible for the Combined ISC Class Award the team must have a minimum of one clean ISC run and a run that has a maximum of 5 course faults (no time faults allowed) for those scores to be used to compute the Combined Score. The Combined Class winner from the 12, 16, 20 and 24 inch heights are invited to attend Team Tryouts. They do not need to fulfill the required scores. The team must also send in all the required information with the fees and the entry form and meet all the other basic eligibility noted in this document (including an approved pedigree). The handler at tryouts must be the same handler that won the combined award.
