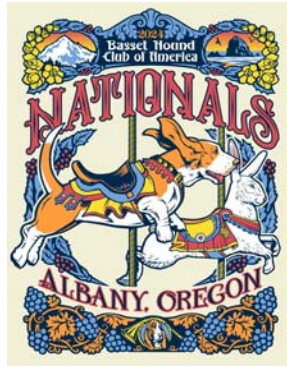

## Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at [k9sports22@gmail.com](mailto:k9sports22@gmail.com) or by phone (503) 840-4303 (cell).

**SITE INFO:** This trial will be held in two rings indoors on packed dirt. There will be crating on the area above the arena, in front of the bleachers. **CRATING WILL BE ON A FIRST COME FIRST SERVE BASIS.** Please DO NOT crate dogs along the railing overlooking the arena. You may set chairs along the railing. There will be a scent work trial running in conjunction with the agility trial. They will be using the North End of the Calapooia Building. It will be marked off so please do not cross that barricade and do not crate in that area. **You will be able to set up your crating space on Wednesday morning.**

### DIRECTIONS TO THE TRIAL SITE:

#### *From the North, on I-5:*

1. Take EXIT 234A toward Fair/Expo/Knox Butte.
2. Turn slight right onto Airport Road SE
3. Turn right onto Pacific Blvd. SE/OR-99E N.
4. Stay straight to go onto Knox Butte Road E.
5. End at 3700 Knox Butte Road E.

#### *From the South, on I-5:*

1. Take Exit 234 toward Fair/Expo/Knox Butte.
2. Turn right onto Knox Butte Road E.
3. End at 3700 Knox Butte Road E.

**We will NOT be using the agility gate app at this trial. We will have regular paper gate sheets.**

**MEASURING:** All dogs without height cards will have to be measured before they run. We will have a VMO available at this trial. Measuring will take place near the secretary table.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

**MOVE-UPS:** The deadline for pre-trial move-ups is Monday, Sept 9th at 6 pm and must be submitted in writing (email ok).

**VOLUNTEERS:** We'll need your help to keep the rings running smoothly.

**PRELIMINARY RUNNING ORDER:** The Preliminary Running Order is contingent on move-up entries not yet received.

**COURSE MAPS:** There will not be paper copies of course maps at this trial. There will be one copy of the course maps posted at the secretary's table to photograph.

**FOOD:** Ground Mobile coffee will be on site from 8am to 10:30 am. They will have some breakfast items. The Food Concession in the Main Pavilion Building will be open for lunch.

**PHOTOGRAPHER:** Whitney Grissom will be taking photos and will have a table set up to view photos at the trial. Photos are 10\$ per photo with a cap of \$60 for all photos. Paypal, venmo, and cash will be accepted at the trial. Priority of cropping, editing, and posting will be given to those that pay at the show. Photos will be added to my pixieset album [Basset Nationals Agility trial](#) for later view, purchase, and download. A form will be available to leave your information and be notified when photos are finished.

**RESULTS, RIBBONS & AWARDS:** Class results will be posted in a binder at the ribbon table.

**Specific Prizes for Basset Hounds:**

Unless otherwise indicated all agility classes are offered by BHCA through the generosity of the membership and there will be rosettes and a BHCA Logo Medallion for 1st through 4th place.

High Scoring Dog in Trial Basset will receive a large rosette through the generosity of the membership, and a Carhart Logo Tote, donated by Jan Allison and Sara Watson.

The highest scoring dog will be determined as the dog with a 2 run total closest to 200 in Standard and JWW Classes. If a tie, then the fastest combined YPS will determine the winner.

DIRECTIONS: Head north on the Expo PKWY NE toward Knox Butte Rd E. Turn left onto Knox Butte Rd E. Continue onto Pacific Blvd SE. Use the middle lane to stay on Pacific Blvd SE. Use the right lane to take the US-20 ramp toward City Center/Corvallis. Turn right onto SW Lyon St/US-20 W & proceed almost a mile across the Willamette River Bridge & at bottom turn right onto NW Springhill Dr. Proceed 0.2 miles on NW Springhill Dr & turn left onto NW Hickory St continuing 0.3 miles. Destination is on your right. Distance from Expo Center is 4 miles.

DIRECTIONS: Head north on the Expo PKWY NE toward Knox Butte Rd E. Turn left onto Knox Butte Rd E. Continue onto Pacific Blvd SE, keep left to stay on Pacific Blvd SE. Turn right onto SW Queen Ave. Continue straight onto Oakville Rd N, Oakville Rd turns Right and becomes OR-34W. Use the left two lanes to turn onto OR-34. Take the OR-99W/south ramp to Junction City/S Corvallis. Follow OR-99W S/SW 3<sup>rd</sup> St/Pacific Hwy W. Willamette Veterinary Hospital will be on the right. Distance is 14.8 miles & 22 minutes.

**HOSPITAL:** Samaritan Albany General Hospital is located at 1046 6<sup>th</sup> Ave. SW, Albany, OR 97321, open 24 hours a day (541) 812-4000. Directions and maps are available from the trial secretary and will also be posted at the trial site.
