Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at K9sports22@gmail.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the area outside the arena, around the bleachers. **CRATING IS ON A FIRST COME FIRST SERVE BASIS.** If you do crate inside we're gonna come to you first if we need workers. **WITH THE LOW ENTRIES WE ARE REALLY GOING TO NEED YOUR HELP TO KEEP THINGS RUNNING. You will be able to set up after 4pm on Thursday. If you manage to find a way in and set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area, photographer space, etc.**

ALSO NOTE: THERE WILL BE A BIG EVENT MOVING INTO THE LIVESTOCK BUILDING RIGHT AFTER OUR TRIAL. THEY WILL BE UNLOADING SEMI TRUCKS IN THE BACK AREA AND WILL BE DRIVING THOSE TRUCKS AROUND THE STALL BARN BACK THERE DURING OUR TRIAL. WHAT THAT MEANS TO US IS THAT WE WILL NOT BE ABLE TO PARK ANY RV'S IN THE BACK ON THIS WEEKEND. ALL RV'S WILL BE OUT FRONT, HOPEFULLY ALL OF THEM ON THE PAVEMENT. GENERAL PARKING WILL BE OUT IN THE GRAVEL ARE OR OVER IN THE LARGE PARKING LOT IN FRONT OF THE ICE ARENA.

DIRECTIONS TO THE TRIAL SITE:

From North of Eugene

Travel south bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7th Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11th Ave. at the light. Turn left on Polk Street and travel to 13th Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

From South of Eugene

Travel north bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7th Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11th Ave. at the light. Turn left on Polk Street and travel to 13th Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

AGILITY GATE APP: We will be using the Agility Gate App at this event. **The code is 4303.** If you don't yet have the App on your phone or tablet, go to the Play Store, search Agility Gate and download the free app.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

COURSE MAPS: Per AKC rules, we are not allowed to release course maps until the day of the trial. We are only required to have a posting copy available on site. As a courtesy to you, I will post course maps on my website some time after midnight of the trial day. An email will be sent out to you prior to the trial with a link to the pages where the maps will be posted and instructions for how they work. PLEASE DO NOT TEXT ME AT 5AM IF THEY ARE NOT AVAILABLE. I DO THE BEST I CAN TO ACCOMMODATE BUT SOMETIMES I FALL ASLEEP BEFORE I RECEIVE THE MAPS.

MOVE-UPS: The deadline for move-ups is Monday, November 18th at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

VOLUNTEERS: You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**. The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

FAST CLASS WALK THRU We will have an open walk thru for ALL FAST prior to the start time (walk thru will last about 30 minutes – while T2B is running).

Walk through groups may be changed at the trial to accommodate for workers.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a “C” instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.
