#### **Running Order and Class Information**

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at <u>K9sports22@gmail.com</u> or by phone (503) 840-4303 (cell).

**SITE INFO:** This trial will be held in two rings indoors on packed dirt. Face coverings are optional at this event.

We will be keeping with some of the other protocol items like only the next 3 dogs and handlers may be in the center area to the rings. **No seating or videoing from that center area will be allowed**. This has proven to be very good for the dogs keeping that area less congested.

#### DIRECTIONS TO THE TRIAL SITE:

*From I-5:* Take EXIT 9 (in Washington), head West on 179<sup>th</sup> Ave. for ½ mile, turn left onto 2<sup>nd</sup> Ave., then turn left again at Gate 7 (or Purple gate). Exposition and Equestrian Bldg. is on the right, at the end of the road. Feel free to park in any marked parking spot around the arena building. Please do not block any arena entrance or access road.

### AGILITY GATE APP: We will be using the Agility Gate App at this trial. The access code is 4303

FAST CLASS WALK THRU、We will have an open walk thru for ALL FAST prior to the start time (walk thru will last about 30 minutes – while T2B is running).

# Walk through groups may be changed at the trial to accommodate for workers.

**High in Trial (HIT):** Award will be a choice of vest or jacket with PAC Logo, HIT, and date up to \$55 in value, or a certificate for future entry to a PAC trial valued at \$55. Any additional add-on will be at expense of winner. HIT is for Master-level runs on Saturday only, to be awarded Sunday morning in the general briefing. The highest combined score from the STD and JWW rounds for small (8" & 12"), medium (16" & 20"), and large (24" & 24C") dogs in the regular classes, and small (4", 8" & 12") and medium (16" & 20") dogs in the preferred classes, will win. Qualifying scores in both classes are required with a score of 100 in both JWW and STD runs to be in contention. Scoring is based on the highest combined YPS. In case of a tie, the dog with the fastest YPS in the STD run will win. All prizes will be awarded during the trials though HIT awards will be mailed.

**Perfect Day award:** 4 Q's on Friday or 4 Q's on Saturday will receive an entry certificate worth 4 runs at a PAC trial. 4 Q's are defined as a Q in STD, JWW, Premier STD, and Premier JWW each on the same day.

**Class Level awards:** PAC will award a High Combined in Trial for each level for Saturday's STD and JWW qualifying runs. This is open to all dogs entered into the trial, regardless of breed. Award is a certificate for 2 runs at a future PAC trial and rosette. The dog's STD level determines level. In case of a tie of points, the dog with the highest average YPS will win, and if still a tie the dog with the fastest YPS in the STD run will win. **Excellent Level** (excludes Master): The highest scoring dog will be determined as the dog with a 2 run total closest to 200 in STD and JWW classes on Saturday's runs. **Open Level**: The highest scoring dog will be determined as the dog with a 2 run total closest to 200 in STD and JWW classes on Saturday's runs.

All prizes will be awarded during the trials and none will be mailed. Awards will only be given for qualifying scores. A rosette and jump bar will be offered to any dog completing a MACH or PACH at these trials.

**MEASURING:** All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs. "The Sneetches got really quite smart on that day. **MOVE-UPS**: The deadline for move-ups is Monday, January 1, 2024 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

**GENERAL WALK THROUGHS:** Walk through sections will be marked on the running orders and copies will be emailed and posted in the building.

**VOLUNTEERS:** As you know, shows could not run without the generosity of our fellow competitors! We will insure that your working does NOT interfere with a walk through or running a course. You will be provided with a coupon good towards future PAC entries. We will also use a white board for worker sign ups.

**CRATING:** Crating is on a first come/first served basis. There is plenty of space around the arena.

#### INDOOR CRATING WILL BE OPEN AT <u>4PM</u> ON THURSDAY, IF YOU SET UP PRIOR TO THIS TIME WE RESERVE THE RIGHT TO MOVE YOUR ITEMS IF THEY CONFLICT WITH SET UP FOR THE TRIAL. COURSE BUILDERS AND SET UP CREW HAVE FIRST CHOICE OF CRATING SPACE
