Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at K9sports22@gmail.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings under cover in a partially enclosed arena on packed dirt. You can crate outside on dirt around the periphery of the arena building or you may crate in the Show Stadium building a short distance from the rings. **You may set up your crating space Thursday afternoon beginning at 4 pm.**

DIRECTIONS TO THE TRIAL SITE:

From the North, on I-5: Take EXIT 258. Turn south onto Portland Rd NE. Turn left onto Lana Ave. At Silverton Rd., stay straight and cross through the intersection to enter fairgrounds.

From the South, on I-5: Take Exit 256 – Market Street. Turn left onto Market Street. Turn right onto 17th Street NE. Turn right onto Silverton Rd NE. Turn right at Lana Ave. to enter the fairgrounds.

Once you've entered the fairgrounds, follow the gravel road through the gate into the fenced parking area. Turn right and head West toward the white stall barns. When you get to the stall barns you will see the arena on your left, across the field. RV Parking for electrical hook-ups only is located on the East side of the stall barns along the fences. The FULL Hook-ups are located on the East side of the Race Barns. As you follow the gravel road into the fairgrounds, turn left (instead of right towards the arena). The full hook-ups will be on the right. RV parking is on a first come, first served basis.

AGILITY GATE APP: We will be using the Agility Gate App at this trial. The access code is 4303

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, the smaller class will take precedence.

FAST CLASS WALK THRU We will have an open walk thru for ALL FAST prior to the start time (walk thru will last about 30 minutes – while T2B is running).

Walk through groups may be changed at the trial to accommodate for workers.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

MOVE-UPS: The deadline for pre-trial move-ups is Monday, July 26, 2024 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

VOLUNTEERS: You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**. The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

GENERAL WALK THROUGHS: Walk through sections will be marked on the running orders and that will be emailed to all exhibitors after the move up date.

FOOD: There will be food provided for workers. **No Food Vendor will be available so plan accordingly.** Please bring your own (BYO) sports bottle, drinking glass, coffee cup, travel mug or other drinking container. Purified drinking water will be provided near the score table. The water will be in Igloo containers.

HOSPITAL: Salem Hospital is located at 890 Oak Street Southeast, Salem - (503) 561-5200 open 24 hours a day. Directions and maps are available from the trial secretary and will also be posted at the trial site.

MACH, PACH: If you think you'll be earning your MACH or PACH at this trial, we ask that you please come and remind someone at the Score Table prior to the run you think you'll earn it on. As we are often preoccupied with trial and scoring duties, we may be distracted and wouldn't want to miss celebrating your Championship with you. So again, please come and remind us or send someone to remind us and we'll be ready with a ribbon.

SCENT WORK AT OREGON STATE FAIRGROUNDS: There will be a Scent Work trial going on this same weekend. They will be in many areas of the Fairgrounds. Please be respectful of their marked off areas and do not walk your dogs there. Here is information that was sent to me:

We will be using the Livestock Pavillion, the Natural Resource Area, and the lawn areas west of the Poultry building and South to Columbia Hall throughout the weekend for search areas. Please remind agility folk we'll be there and to not disturb areas posted for searches. Search areas change everyday so not easy to say where we will or wont be in advance. Also important to keep dogs on leash at all times. As always agility folk are welcome to come over without dogs to watch Scent Work.

B MATCH: We're having a B Match on **Saturday** afternoon one half hour following the last class of the day. \$5 per run. Toys are ok but no food in the rings. Get some extra ring time on your dogs! Dogs do not need to be entered in the regular trials. Dogs may be entered multiple times in the same class with a maximum of 4 runs per dog. Each run will be a maximum of 90 seconds.
