SITE INFO:

This trial will be held in one ring indoors on artificial turf. **Please don't arrive more than 1/2 hour before the morning briefing.**

The show site is indoors on artificial turf. Please bring your own crate, clean up supplies, & water for your dog. **X-pens** are **NOT permitted at the show site**. Dogs must be kept on leash when not in the ring. A warm up area will be provided for all exhibitors.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

Please NO SPIKE SHOES OR HEELS on the turf. Please wear/use clean, athletic footwear to preserve the flooring!

Barking dogs must be kept quiet at all times in consideration of the neighbors.

From the North: Take I-5 southbound to Exit 283 Wilsonville Rd., Wilsonville. Turn right onto SW Wilsonville Rd. Stay on Wilsonville Rd for approx. 5.5 miles. Turn right onto SW Ladd Hill Rd. Stay on Ladd Hill Rd. for approx. .7 mile. Turn left onto SW Kramien Rd., Follow Kramien Rd for approx. .5 mile. Turn right on Parrott Mountain Rd., follow Parrott Mountain Rd for .7 mile. Turn left onto NE Corral Creek Rd. Stay on Corral Creek Rd for 1.9 miles. Corral Creek Dog Sports will be on your right.

From the South: Take I-5 North to Exit 283, Wilsonville Rd., Wilsonville. Turn left onto SW Wilsonville Rd. Stay on Wilsonville Rd for approx. 5.5 miles. Turn right onto SW Ladd Hill Rd. AWARDS:

Please do your best to stay through awards photos on Sunday afternoon. We have some great prizes and ribbons! Here are the details for award eligibility:

MY FIRST ISC Q

For teams who earn their first ISC Q during the trial. This is applies to any class at any level, for your first Q only.

HIGH-IN-TRIAL - LEVEL 1

This prize is open to dogs that are *only* entered in Level 1 courses. You must enter in and compete in at least 4 of the 6 Level 1 courses offered over the three days. Your dog may not be entered in any higher levels to be eligible.

Two tiers will be offered; one tier each for dogs in 16" or lower height classes and one for dogs in 20" and higher height classes. Ribbons will be awarded from 1st to 3rd place in each height group.

Points will be accumulated based on the following system:

Clean Run = 10 points

Single Fault Runs = 7 points

Two Fault Runs = 5 points

Non-E Runs = 3 points

Fastest time in class without an E = Bonus 5 points

NQ RAFFLE

For any team that earns an NQ in any level run, you will drop a raffle ticket in for a special prize. There will be one winner of this prize.

HIGH-IN-TRIAL - LEVELS 2 & 3

This prize is open to dogs that entered any combination of Level 2 or Level 3 courses. You must enter in and compete in at least 4 Level 2 or Level 3 runs over the three days.

Two tiers will be offered; one tier each for dogs in 16" or lower height classes and one for dogs in 20" and higher height classes. Ribbons will be awarded from 1st to 3rd place in each height group.

Points will be accumulated based on the following system:

Clean Run = 10 points

Single Fault Runs = 7 points

Two Fault Runs = 5 points

Non-E Runs = 3 points

Fastest time in class without an E = Bonus 5 points



This prize will be for the peer-nominated dog and handler team that expresses the most joy over the course of the weekend. In their teamwork, in their attitude, in their expressions towards others and their enthusiasm for ISC agility and the challenges it brings.

To be eligible, the handler must be entered in and compete in at least 6 classes over the course of the weekend.

This award will be earned based on nominations from other competitors, the judge, trial committee or volunteers. The individual with the highest number of nominations at the end of the weekend will receive the prize.

Please be sure to nominate your peers!! Nominations will be anonymous and drawn on Sunday following the jumpers runs.

Measuring will take place near the secretary table.
