The show site is indoors on artificial turf. Please bring your own crate, clean up supplies, & water for your dog. **X-pens are NOT permitted at the show site**. Dogs must be kept on leash when not in the ring.

Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. *Please NO SPIKE SHOES OR HEELS on the turf. Please wear/use clean, athletic footwear to preserve the flooring*!

Please drive slowly on McNay Road to keep dust down for our neighbors. Park near your neighbors, as parking will be tight. DOGS MAY NOT BARK UNLESS ACTIVELY RUNNING A COURSE. This is extremely important to keep our neighbors happy and to allow us to continue using this facility.

#### Barking dogs must be kept quiet at all times in consideration of the neighbors.

#### **Directions**

**From the North**: Take I-5 southbound to Exit 294 to Hwy 99W (Tigard). From 99W take exit on right to Hwy 217 (Northbound). From Hwy 217 take Exit 4. At stop light, turn left onto SW Scholls Ferry Rd. (OR 210) Travel approx. 7.3 miles. At the traffic circle, take the 3<sup>rd</sup> exit onto SW Scholls Ferry Rd. (OR 210) Travel approx. 1.8 miles. Turn right onto Hwy 219 (Laurel Hillsboro Hwy). Travel for approx. 1.8 miles. Turn left on SW Laurel Rd. Turn left on SW Campbell Rd. Then turn left on McNay Rd. Bravura Farms is on the left.

**From the South**: Take I-5 North to Exit 289, Nyberg St., Tualatin. Turn left onto SW Tualatin-Sherwood Rd. (Nyberg). Stay left to stay on Tualatin-Sherwood Rd. for approx. 4.5 miles to crossroad 99W. Stay straight to continue on Roy Rogers Rd. for approx. 1.3 miles. Turn left onto SW Scholls Sherwood Rd. and follow to the right to stay on SW Scholls Sherwood Rd. for approx. 4.3 miles. At intersection, turn left onto SW Scholls Ferry Rd. (OR 210). Travel for approx. .7 miles and turn right onto Hwy 219. Turn right onto Hwy 219 (Laurel Hillsboro Hwy). Travel for approx. 1.8 miles. Turn right onto Hwy 219 (Laurel Hillsboro Hwy). Travel for approx. 1.8 miles. Turn left on SW Campbell Rd. Then turn left on McNay Rd. Bravura Farms is on the left.

**MEASURING:** All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs. **Please note** there is no garbage can for poop disposal. Please take it with you.

**MOVE-UPS**: No move-ups at this event.
