SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the area outside the arena, around the bleachers. CRATING IS ON A FIRST COME FIRST SERVE BASIS. If you do crate inside we're gonna come to you first if we need workers. WITH THE LOW ENTRIES WE ARE REALLY GOING TO NEED YOUR HELP TO KEEP THINGS RUNNING. You will be able to set up after 4pm on Thursday. If you manage to find a way in and set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area, photographer space, etc.

# NEW ENTRANCE INFORMATION FOR SATURDAY ONLY AT THIS TRIAL

ON JUNE 29<sup>TH</sup> THERE IS A CAR SHOW EVENT IN THE MAIN PARKING LOT AT THE FAIRGROUNDS, WHICH MEANS WE ARE UNABLE TO ENTER THROUGH THE 13<sup>TH</sup> AVE ENTRANCE LIKE WE NORMALLY DO. ON <u>SATURDAY ONLY</u> WE MUST ALL ENTER AND EXIT FROM THE 15<sup>TH</sup> STREET ENTRANCE ON THE WEST SIDE OF THE FAIRGROUNDS, AS SHOWN ON THE PHOTO ON THE NEXT PAGE.

THOSE OF YOU ENTERING WITH RV'S ON SATURDAY, IT WILL BE EASIER TO COME DOWN POLK STREET VS TYLER STREET. POLK IS A LARGER ROAD TO MANEUVER ON.

#### **DIRECTIONS TO THE TRIAL SITE:**

#### From North of Eugene

Travel south bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7<sup>th</sup> Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11<sup>th</sup> Ave. at the light. Turn left on Polk Street and travel to 13<sup>th</sup> Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

#### From South of Eugene

Travel north bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7<sup>th</sup> Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11<sup>th</sup> Ave. at the light. Turn left on Polk Street and travel to 13<sup>th</sup> Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

**AGILITY GATE APP:** We will be using the Agility Gate App at this event. The code is 4303. If you don't yet have the App on your phone or tablet, go to the Play Store, search Agility Gate and download the free app.

**MEASURING:** All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

COURSE MAPS: Per AKC rules, we are not allowed to release course maps until the day of the trial. We are only required to have a posting copy available on site. As a courtesy to you, I will post course maps on my website (k-9sports.com) some time after midnight of the trial day. An email will be sent out to you prior to the trial with a link to the pages where the maps will be posted and instructions for how they work. PLEASE DO NOT TEXT ME AT 5AM IF THEY ARE NOT AVAILABLE. I DO THE BEST I CAN TO ACCOMMODATE BUT SOMETIMES I FALL ASLEEP BEFORE I RECEIVE THE MAPS.

**MOVE-UPS**: The deadline for Pre-Trial move-ups is Monday, June 24th at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

**VOLUNTEERS:** You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**, The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.
