SITE INFO: The members of Rose City Classic express their deepest thanks to the members of the Portland Agility Club for their generosity in donating a ring of SynLawn Speed Turf in honor of Janet Mendel-Hartvig.

This trial will be held indoors in a climate-controlled building, two rings on NEW SYNLAWN SPEEDTURF ARTIFICIAL TURF. I've attached a diagram of the facility. AGILITY EXHIBITORS...PLEASE ENTER THROUGH THE DOOR ON THE FRONT SOUTH CORNER OF E HALL. I PUT "EXHIBITOR ENTRANCE DOOR" WHERE THAT IS LOCATED.

DIRECTIONS TO THE TRIAL SITE:

FROM I-5 NORTH OR SOUTHBOUND – Take exit 306B to get to the east side reserved/general parking entrance or take exit 307 Marine Dr. West to get to the Force Ave west side reserved parking entrance or to circle around the Expo to get to the exhibitor express entrance.

AGILITY GATE APP: We will be using the Agility Gate App at this trial. The access

CODE IS 4303 If you do not yet have the app you can download it from the Play Store on your phone or tablet. Search for Agility Gate and download it. Open the app, search for Rose City Classic, tap that and tap on the class you want. When the running orders are available you can check your dog in by touching your dog's name and swiping it from right to left. You'll then see options to check-in, conflict, scratch, or FEO (if applicable). Touch the option you want and you're all set. You can follow along on the app to see live where we are in the running orders. PLEASE CHECK YOUR DOG IN SO WE KNOW THAT YOU ARE PLANNING TO RUN, OR SCRATCHING, OR.... You can even do this from your home. That way we aren't searching for you if you are not going to make it for any reason.

COURSE MAPS: Course maps for each day will be posted each morning at the trial site. Course maps will also be posted on the Agility Gate App with the daily running order. Additionally, the trial secretary may post the course maps on K-9 Sports website when time permits. NO INDIVIDUAL PHYSICAL MAPS WILL BE AVAILABLE FOR COMPETITORS.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

MOVE-UPS: The deadline for pre-trial move-ups is Monday, Jan 13, 2025 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

MACH/PACH: We want to celebrate with you on your achievements so if you're close to getting your MACH/PACH, let me know so we will be ready with a ribbon.


FOOD: There are several food vendors available on site.

VOLUNTEERS: As you know, shows could not run without the generosity of our fellow competitors. With only one ring volunteering won't interfere with your runs. You help is always greatly appreciated. We'll have a worker raffle drawing each day.

GENERAL WALK THROUGHS: We will have walk throughs as noted in the above chart of classes. If you anticipate having a conflict with conformation, obedience, rally or any other event, maybe walk with an earlier group.

SET UP: The agility area will be prepared Wednesday morning. We anticipate that the area will be available for setup after 4pm. If you set up early and we need to move your stuff, we will do that. We plan to be on site at 3pm and will coordinate set up then. We will have some spaces reserved for our chief workers and should have them identified by 3pm on Wednesday. Please coordinate with the workers on site to set up in the proper space.

CRATING: NO X-Pens allowed in the agility area. We all need to work together to share spaces so we can accommodate all entered dogs. Crating is on a first come/first served basis. You can crate along the wall in rows shown in the diagram below. You can set your chairs next to the ring. I have also attached to the email a layout of E Hall where we run agility. You can see where they are allowing crating. I marked off an area to the right of the doors at the bottom for equipment storage.

POTTY AREAS: Potty areas are provided with shavings and tools to pick up after them. DO NOT potty your dogs in the landscaping. It is a benchable offense to allow your dog to relieve themselves in the landscaped areas on the Expo site. This also extends to the business park to the West of the site.

CONFLICTS: With all the different activities this weekend, we understand there will be many conflicts and will do our best to accommodate them. If you have a conflict, please mark yourself as conflict on the Agility Gate app so we know ahead of time that you may need to run earlier or later in a class. You can also come talk to me (Lori Sage) or the gate stewards to coordinate a change.

VETERINARIAN: VCA Southeast Portland Animal Hospital, 13830 SE Stark St., Portland, OR 97233 Their phone number is 503-255-8139. They are open 24 hours a day, 365 days a year. The driving directions from the show site are as follows: Head east on Marine Dr W toward N Pier 99 St. Turn right to merge onto I-5 S. Slight right onto U.S. 30 E (signs for I-84 E/The Dalles). Continue onto I-84 E. Take exit 7 for Halsey St. toward Gateway **District.** Keep right at the fork, follow signs for 99th Avenue and merge onto NE 99th Ave. Turn left onto E Burnside St. Turn right onto SE 122nd Ave. Turn left onto SE Stark St., and the destination will be on the right.

HOSPITAL: Southwest Washington Medical Center is located at 3400 Main St., Vancouver, WA 98663 (360) 256-2000, open 24 hours a day. Directions and maps are available from the trial secretary and will also be posted at the trial site.
